- Where the tax-free threshold is **not** claimed and your employee earns:
- more than \$10,833.33 but less than \$13,481.00 withhold \$3,818 plus 39.00 cents for each \$1 of earnings in excess of \$10,833.33
 - more than \$13,480.99 withhold \$4,849 plus 49.00 cents for each \$1 of earnings in excess of \$13,480.99.
